### **BY REGISTERING FOR THE EVENT, YOU ACCEPT THE FOLLOWING TERMS AND CONDITIONS.**

#### **EVENT DISCLOSURES**

1. You may only register for and attend the Event in accordance with these Terms.
2. To register for the Event, you must complete the Event registration process.
3. Unless otherwise stated on the Event website or unless we expressly advise you otherwise, **you must be at least 18 years of age on the first day of the Event.**
4. Registration for the Event is subject to availability at any given time and may close prior to the published deadline, as we may decide in our sole discretion.
5. We may also change the Event program at any time at our sole discretion.
6. DANOSA as a responsible entity for the event, will provide the following processes and procedures which may be relevant to your attendance:
  - a. Provide food and beverage in event's spots such as Fontanar's Factory (Guadalajara – Spain) and Ciudad de la Raqueta (Madrid – Spain).
  - b. Will provide to selected Attendees hospitality and transfer. These attendees will be previously informed by the organization during the registration process.
7. Any other cost related to the event must be covered by the Attendee.
8. The Attendee will be responsible for managing and issuing any documentation required to travel to Spain to attend the event and any cost out of the scope of the event.
9. The Attendee will at all times comply with DANOSA Code of Conduct.
10. **Risk Assumption:** The Attendee acknowledge and agree that its attendance and participation in the Event is voluntary and that you understand the nature of the Event. To the fullest extent permitted by law, you assume solely the risks associated with attending and participating in the Event.
11. **Limitation of Liability:** DANOSA and our affiliates and licensors shall have no liability to you under any legal proceeding or theory of liability, even if a party has been advised of the possibility of such damages for a) indirect, incidental, special, direct or exemplary damages; or b) lost profits or loss of revenue, customers, opportunity or goodwill.
12. **Right of admission:** Access to the event will be denied to any Attendee who:
  - a. Not present their access QR code when requested by the Organizer, either in digital or printed format, or failure to provide their full name for possible identification in the list of registered attendees.
  - b. Can rationally be presumed to imply a situation of risk or danger to himself or others, due to rowdiness or states of apparent or potential intoxication, the bearer

being personally liable in all cases with his own actions and omissions that cause injury to third parties or damage to things.

- c. That violate any of the rules of this document, other rules that the Organizer has expressed or go against the General Police Regulation of Public Entertainment and Recreational Activities Royal Decree 2816/1982 of August 27, especially in reference to Articles 59, 60 and 61. For which appropriate measures will be taken such as registration to avoid carrying dangerous objects.

## **DATA PRIVACY & THIRD PARTY TRANSFER**

DERIVADOS ASFALTICOS NORMALIZADOS, S.A. ("DANOSA") is the **Data Controller** for the personal data of the **Interested Party** and informs them that these data will be processed in accordance with the provisions of Regulation (EU) 2016/679, of April 27 (GDPR), and Organic Law 3/2018, of December 5 (LOPDGDD). Therefore, the following information about the processing is provided:

**Purposes and legitimacy of the processing:** Maintain a business relationship, being invited to events organized by DANOSA such as attendance to 60<sup>th</sup> Anniversary, with the possibility of processing travel for such purposes (in the legitimate interest of the controller, art. 6.1.f GDPR), and sending communications about products or services (with the consent of the interested party, art. 6.1.a GDPR).

**Data retention criteria:** They will be kept for no longer than necessary to maintain the purpose of the processing or as long as there are legal prescriptions that dictate their custody. When no longer necessary, they will be deleted with appropriate security measures to ensure data anonymization or total data destruction.

**Communication of data:** Your data may be transferred to third parties as necessary to achieve the purpose of the processing or by legal obligation.

In accordance with the Organic Law 3/2018, of December 5, on the Protection of Personal Data and guarantee of digital rights your data will be included in a file owned by THE ORGANIZER and may be used to manage your participation in THE ORGANIZER's event as well as to be informed of issues related to the event.

You are also informed of the possibility of exercising your rights of access, rectification, cancellation and opposition at the address of THE ORGANIZER.

### **Rights of the Interested Party:**

- Right to withdraw consent at any time.
- Right of access, rectification, portability, and deletion of their data, and limitation or opposition to their processing.
- Right to file a complaint with the supervisory authority ([www.aepd.es](http://www.aepd.es)) if they believe that the processing does not comply with current regulations.

## RECORDINGS (VOICE & IMAGE)

THE ASSISTANT may appear in images taken by different means for subsequent dissemination through any media.
